LUIS VELEZ,

BEING FIRST DULY SWORN, WAS EXAMINED AND TESTIFIED AS FOLLOWS:

THE CLERK: BE SEATED, PLEASE, AND STATE YOUR NAME
FOR THE RECORD.

THE WITNESS: MY NAME IS LUIS VELEZ.

DIRECT EXAMINATION

BY MR. MOYE:

Q. WOULD YOU SPELL YOUR LAST NAME, MR. VELEZ, FOR THE COURT
REPORTER?

A. V, LIKE IN VICTOR, E-L-E-Z.

Q. MR. VELEZ, HOW ARE YOU EMPLOYED?

A. I'M A SPECIAL AGENT WITH BUREAU OF ALCOHOL, TOBACCO AND
FIREARMS.

Q. HOW LONG HAVE YOU BEEN WITH ATF?

A. APPROXIMATELY FOUR YEARS.

Q. MR. VELEZ, CAN YOU BRIEFLY TELL US WHAT THE DUTIES AND
RESPONSIBILITIES OF THE BUREAU OF ALCOHOL, TOBACCO AND FIREARMS
ARE?

A. WE ENFORCE THE FEDERAL FIREARMS VIOLATIONS AND EXPLOSIVE
FEDERAL FIREARM AND EXPLOSIVE VIOLATIONS.

Q. LET ME HAND YOU EXHIBIT 4, AND ASK YOU IF YOU RECOGNIZE

1 THIS ITEM?

2 A. YES, SIR, I DO.

3 Q. WHAT IS THAT?

4 A. IT'S A .25 CALIBER EXCAM SEMI-AUTOMATIC PISTOL.

5 Q. MR. VELEZ, DID THAT PISTOL COME INTO YOUR POSSESSION AT
6 SOME POINT?

7 A. YES, SIR, IT DID.

8 Q. AND DO YOU KNOW WHEN IT CAME INTO YOUR POSSESSION?

9 A. APPROXIMATELY IN JULY OF LAST YEAR.

10 Q. AND HOW DID IT GET INTO YOUR POSSESSION? WHO GAVE IT TO
11 YOU?

12 A. AS A RESULT OF -- SPECIAL AGENT BILL SALINSKI OF THE
13 INTERNAL REVENUE SERVICE.

14 Q. MR. VELEZ, WHILE THAT PISTOL WAS IN YOUR POSSESSION, WERE
15 YOU ABLE TO DETERMINE WHETHER IT WORKED?

16 A. YES, SIR. I WAS ABLE TO TEST FIRE IT AND FOUND IT TO
17 FUNCTION AS DESIGNED.

18 Q. WHAT IS THE SERIAL NUMBER ON THE PISTOL?

19 A. IT'S GOING TO BE M, LIKE IN MIKE, I, LIKE IN IDA, 99728.

20 MR. HOYE: THANK YOU, MR. VELEZ. I HAVE NO FURTHER
21 QUESTIONS ON DIRECT EXAMINATION.

22 THE COURT: MR. MORRISON?

23 MR. MORRISON: NO QUESTIONS.

MR. MOYE: CALL SPECIAL AGENT BRIAN CHAMBERS.

BRIAN CHAMBERS,

THE WITNESS: BRIAN CHAMBERS, C-H-A-M-B-E-R-S.

DIRECT EXAMINATION

BY MR. MOYE:

Q. HOW ARE YOU EMPLOYED?

A. I'M A SPECIAL AGENT WITH THE DRUG ENFORCEMENT
ADMINISTRATION, ASSIGNED TO THE MEMPHIS, TENNESSEE OFFICE.

Q. HOW LONG HAVE YOU BEEN WITH D.E.A.?

A. I'VE BEEN WITH D.E.A. ABOUT SIX YEARS.

Q. MR. CHAMBERS, LET ME ASK YOU, SIR, IF YOU ARE FAMILIAR
WITH ONE RONNIE WOODS?

A. I AM.

Q. HOW ARE YOU FAMILIAR WITH RONNIE WOODS?

A. WE CONDUCTED AN INVESTIGATION ON MR. WOODS AND WE ARRESTED
MR. WOODS.

Q. MR. CHAMBERS, IN THE COURSE OF THE INVESTIGATION, DID YOU
CONDUCT COURT-AUTHORIZED ELECTRONIC SURVEILLANCE OF MR. WOODS?

A. I DID.

1 Q. LET ME DIRECT YOUR ATTENTION, IF I MAY, TO MARCH 7TH,
2 1991, AND ASK YOU, SIR, IF ON THAT DAY IN THE COURSE OF THE
3 ELECTRONIC SURVEILLANCE THERE WERE TELEPHONE CALLS THAT WERE
4 INTERCEPTED THAT RELATED TO A NARCOTICS MATTER?

5 A. THERE WAS.

6 Q. WOULD YOU TELL THE LADIES AND GENTLEMEN OF THE JURY ABOUT
7 THOSE TELEPHONE CALLS THAT WERE INTERCEPTED?

8 A. MARCH 7TH, 1991 THERE WERE SEVERAL PHONE CALLS INTERCEPTED
9 FROM MIAMI, FLORIDA TO MEMPHIS, AND FROM MEMPHIS TO MIAMI,
10 FLORIDA TO RONNIE WOODS TO A MALE SUBJECT BY THE NAME OF
11 ARMANDO. DURING THE COURSE OF THE CONVERSATION, IT WAS SAID ON
12 THE TELEPHONE CONVERSATION ABOUT MY BOYS SHOULD BE UP THERE,
13 THEY ARE COMING UP THERE, YOU NEED TO GET THOSE THINGS OUT OF
14 THE CAR. WE KIND OF PUT EVERYTHING TOGETHER, MEANING THIS WAS
15 NARCOTIC CONVERSATION BETWEEN RONNIE WOODS AND ARMANDO.

16 Q. AT SOME POINT IN THE COURSE OF THESE TELEPHONE
17 CONVERSATIONS WERE YOU ABLE TO DETERMINE WHETHER OR NOT SOMEONE
18 THAT WAS BEING TALKED ABOUT IN THESE CONVERSATIONS HAD ARRIVED
19 IN MEMPHIS, TENNESSEE?

20 A. WE WERE.

21 Q. WHERE HAD THEY ARRIVED?

22 A. THE LAQUINTA HOTEL IN MEMPHIS, WHICH IS LOCATED ON CAMILLA
23 IN MEMPHIS.

24 Q. IS THAT THE DOWNTOWN MEMPHIS AREA?

25 A. DOWNTOWN AREA.
