RE: Will The real Virginia C. High Standup?

Virginia;

I am writing this letter to address certain issues that has plagued our marriage and relationship since we got out of prison. I have discussed all of these problems with you on numerous occasions over the last two years, all to no avail, so I decided to put "pen to paper," at which I am well blessed and able to do. I have been portrayed as the villain, when I am in fact the victim.

**I swear to tell the truth, the whole truth and nothing but the truth
"So Help Me God"**

LEGAL ISSUES

1. The transcript contains 95 pages of your testimony at trial, primary against me. The only other person who testified against me was Sims Jinks (Bubba), on count 15, and I was acquitted on that charge. I emphatically told you not to testify at trial.
2. High's Realty had 3 bank accounts, (operating, interest bearing escrow and non interest bearing escrow), Georgia Home Improvement had a bank account, High-Five had two bank accounts and we had joint checking and saving account. You opened a separate bank account at the black bank on Panola road and you did not add my name on that account and you later secured a 2nd mortgage of \$150,000 on a property that was titled in your name (Riversound) and you deposited that check in your personal account. Later that account (\$15,000) was seized by the government just prior to your arrest on June 17, 1992 That was the only bank account the government seized.
3. At trial, David Wallace, Anna Grazette, Sims Jinks, Jo Jo, Kyle Henry and others testified against you at trial. (I have proof)
4. From 1994 up until we got out of prison you filed numerous motions, petitions, and appeals, in your name only and not once up until this very day have you ever included George High on/in anything filed in the courts.
5. Since 1997, I have filed no less than 25-30 various briefs, motions, petitions in the district court, appeal court and twice in the U.S. Supreme Court, all in the names of George High and Virginia C. High.
6. Since April 11, 2001, (release from prison) I have submitted 2 appellate briefs to the 11th circuit of appeals on behalf of George and Virginia High. I have also Petition the

United States Supreme Court for a Writ of Certiorari and a Petition for Writ of Error Coram Nobis, Motion for appointment of Counsel and Motion to Disqualify Judge Vining all in the district court.

7. As of the above date I have the following's pending on behalf of myself and you: Petition for En Banc Re-Hearing 11th Cir. Tort Claim for Virginia High in the amount of 6 millions + Dollars. Tort claim for George High 8 million Plus and tort claims for Eric and George Jr. for one million + each. Eric and George Jr. signed an agreement to pay George Sr. 20% of any monies received from the United States Department of Justice and/or the Internal revenue Service. After I submitted the claims to the IRS and the Dept of Justice, you adamantly refused to sign the agreement authorizing George High to represent you. However it comes as no surprise because you have refused to contribute one penny to any litigation by me since 1996, and have refused to pay any filing fees, never bought any copy paper and I asked you to buy the fax and you refused and I have asked you on numerous occasions over the last year to buy me a fax cartridge (\$24.00) and you never did but you make copies always. I have asked you to buy me color and black printer cartridge and you never have. You said you would by the CD burner so you could put all your pictures on CD, so I needed one and I bought it for \$99.00, and you said you would give me the money back and it has now been 5 months. You have never even bought me a book of stamps.

8. You told me one day that you wanted to see about getting off parole early and I told you that you needed to file a motion with Judge Vining. I told you that you could not have it both ways, and I will be litigating and if you wanted to get off parole than I would not include your name on the Appeal I was working on. You said that you was committed to us getting justice so you wanted me to continue the fight for us both. The very day I filed the Appellate Brief in the 11th Cir. And we came back by to see Dennis Tudor (parole officer), you asked him what did you have to do to get off of parole early and he said you need to file a motion in the district court. You really showed me what you thought of me and my legal work. You made me look like a clown.

FINANCIAL ISSUES

1. I late November of 1991, I borrowed \$10,000 from Delores with the understanding that we would buy an investment property to fix up and live in and later sell it for a profit. I bought the truck so we could have transportation. You had started working and I was carrying you back and forth to work and we opened a joint checking and savings account. One Saturday morning in mid December about 5:30 you just got up and started packing your clothes and said that if I didn't find us a place that day that you would move to a hotel, and you refused to spend another night in that house, and you were really very loud and I said lets go to McDonalds and get a cup of coffee. We got the coffee and I told you that I could not find a house that fast and you said just find us a place today. You went to work and I found this place that day and e-mailed the application and met with the owner Sunday, signed the lease and paid the \$500 deposit and the January rent and got the keys. On Monday we went to Sears and looked at Refrigerators, washers and dryers

and you insisted that I buy a side by side for \$800 and washer and dryer for \$500 each. I refused and you got mad as hell, so later that day Monday I bought a ref. Washer and dryer for \$525. We moved on Monday and Tuesday. I noticed that when you got paid, you never deposited you check in our account and you wrote checks from our joint account to pay rent, all utilities, groceries, and all your Christmas shopping was done from our joint account which only had the remnants from the \$10,000 loan and my social security checks. You never deposited any check in our joint account since you started working at JCPenny in November 2001. You opened another personal account, also on Panola rd. at Sun Trust, about two bocks from the one that was seized in 1992.

2. I was almost broke and in March you said that we would use my account (you took your name off) to pay rent and all utilities and use your bank card for groceries and other purchasers and you got me a bank card and added my name to your checking account, but not your savings account. I bought you the Cadillac, paid for the insurance and paid for the headliner, tires, all brake parts. You never had any money in your checking account so I had to put money in your account to use the check card. Finally after I had spent all I had which you added it all up which came to over \$13,000 plus I was paying Delores back \$170.49 monthly and all the money was gone and you even refused to even make one payment to Delores till this day. I remember One day I asked you to use the bank card to get \$11.00 to buy vegetables to make a salad for our family picnic and you said there was not any money in that account.

3. In May you finally agreed to pay rent and utilities every other month, but you have never done any grocery shopping and only gave me \$40.00 over the last 15 months for groceries. You have refused to make any payment to Delores, although you spent all the \$\$\$ that we were suppose to use to get us a house. Now you want to get a house after I'm broke.

4. For my birthday last year you wrote a check from "my account" and bought me a Seiko watch. The only things you have really gave me was a \$12.00 blue jacket from Penny's and a \$25.00 gift certificate. I carried you back and forth to work for 6 months and you never put any gas in the truck. You made it clear from day one and I quote "you ain't going to live off my money," although you lived off mine for 30 + years.

PERSONAL ISSUES

I have lost all trust in you because you have told people things that I told you in the utmost confidence which was suppose to stay in our house and you have caused friction between myself and our sons and Jenique, as follows:

1. I told you that J.R. had asked me if Eric and Jenique had invited us to the fight and I said no and he said Jeniques mother, daddy and brother was there. I told you what happened and told you not to say anything about it. You told Eric and he said something to Jenique and she has not called you since.

2. On another occasion Maxwell made a statement to you about how much the white lady Loved him and I said for you not to say anything to her because they were going to South Carolina to spend 3-4 days in her condo and Jenique's mother is her maid. You told Jenique what Maxwell said and she would not come over for her birthday dinner and cupcakes, and you blew it again and she has not called you in almost a year.

3. On another occasion you told Eric about the house on Sterling Forest and he told you that you should have not offered \$20,000 over the asking price and you should have let me handle the Real Estate. There was also some tax liens against us and Eric told you but you withheld the information about the \$102,000 tax lien from 1991, which is more than enough for me to not trust you ever again.


4. On Friday you called Eric to come over and told him about the House on Snapfinger and also told him that I said: "I don't want to live next door to J.R.", Which was a terrible thing for you to tell Eric because that should have been between us. About an hour after Eric left and J. R. came by and you told him that I said I did not want to live next door to him and he really went off and said the most disrespectful things that I ever heard a son say to a father. He advised you that you should just get your own place. After you left he told me to come and get the my truck the next day.

5. When Charles and Agnes called and y'all agreed to have lunch at the mall, you never said anything to my but when they asked why I was not there you told them I said that they knew where I lived. On Saturday when you got off and was dressed and walking out the door, you said: I don't guess you want to go over to Oliva's with me to see Agnes and Charles and I said you never said anything to me and when did you decide to go and you said y'all had lunch yesterday, so I said you really don't want me to go.

6. I am well aware of the fact that you have told all your family how I got you in trouble and caused you to go to prison and it has been your intent to "let your little light shine" and lay all the blame on me. Over the last 37 years, we have never discussed any of our personal business with Eric or J.R. and now you want to tell them about everything negative about me. You have also said some dreadful things about me.

7. There are hundred's of other things that I did not mention, but at any rate you have 10 days from the above date to respond in writing to any issues that you disagree with, or I will assume that you agree with everything. I have tried to discuss all of the above orally and you refuse to do so.

WILL THE REAL VIRGINIA C. HIGH, PLEASE STAND-UP

April 30, 2004

Virginia,

“Big Ma” use to say: “Give em enough rope and they’ll hang themselves”, and you shore put the rope around your own neck. It seems that I have no choice but to write you a letter, because we cannot communicate without you always turning an issue into a personal attack on me.

Let me begin by saying that on Monday when we were at the cingular store, I asked the lady about us getting a family plan for the 4 phones with one bill and you very bluntly said I want my own bill. I also recall when we were at State Farm last year getting the Insurance on your car you said to the agent: “I want my own insurance policy”. In 2003 when we were at Dennis Tudor’s office you said “I want to know what I have to do to get off parole”, when we had just come from filing a motion in court and you assured me that you wanted to fight. You also said that you wanted your own checking account, saving account, credit cards and your own car. You have insisted on everything separate since we got back on April 11, 2001, and you have become very hateful and selfish and have lost all respect for me (if you ever had any).

You are a very materialistic person and have some misplaced priorities, in as such that from the day we got back you only talked about moving into a house and getting all your furniture back from Olivia. You tried 3 times to buy a house but was not able to so finally you insisted on renting this place (although I was totally against it), so you could have a place to “display” your furniture and for your folks to stay. We have been back for over 3 years and not one person in your family has come to visit you, and the only people who has visited or spend the night is your grand’s. . You have made this a display house and really made the bedroom like a single woman’s room with 2 tables with a TV on them, you’re put some material at the head of the bed and put the pillows in it every morning, you got about \$15,000.00 worth of cosmetics, hair products and facial makeup on the dresser, the bath counter, over the toilet , under the sink and hanging on the bath wall. You got a closet full of cloths, shoes, handbags and God knows what else and you talk about me moving out of “our” bedroom.

It aint never been our bedroom nor has this ever been our house because you have never consulted with me on anything you buy or where you put it. You have placed everything in your house just where you want it and the Living room and dining room is just for show, but no one has seen it but J.R. & family and Eric and his family, and I guess they think you are some kind of fool, because Eric had said he thought we should get an apartment. You put up them stupid blue Cornish boards all over the house, that your sister gave you after the "white-folks" told her to throw them out, along with the stuff you put in the bedroom and more in the garage. You have arranged everything just like "you" want it, so in essence it is your house. You raised all kind of hell when I moved the "pink" dresser out of my office and when I put the shelf on the wall and you said I was getting "obsessed". I don't believe that any wife would ever make such drastic changes without discussing it with her husband, so I do not think of this as our house or our bedroom and you do not consider me as your husband, although I have done everything to make this marriage work but I now know that its over because you have defied our marriage and have not kept your vows (a copy of which is attached).

You move the table in the breakfast room every other day and you now have got new knives, folks, and spoon and I suppose you got rid of the others. You threw away the dish-tray and replaced it with some junk that is too small for anything. You have re-arrange everything on the counter, moved the pots and pans and got rid of the old dishes, and now you can't heat anything in the microwave. It is beyond me that you would take such an interest in the kitchen, because you only cook breakfast for your sons and you never fix lunch, nor do you wash dishes, and you have have not done any real grocery shopping since we lost the food stamps (Jan. 2002). As a matter of fact, just before you left for work this morning, you even asked me if I would go to the store to get some eggs, washing powder and ect.. When you invite your children or grand's over for dinner, then you just get the items that you plan to cook.

You really think that you are smart, but everything you do shows your intelligence, or lack thereof. Are you aware that Georgia is a "common law" State? Which means that anything acquired during the course of the marriage is shared 50/50, so I could get a restraining order and you would not be able to get one dime out your own so-called banking/checking account, and I could get half or everything that we own including your savings and checking accounts, the furniture and everything else. Do you

remember how we went down to McDonough, Ga. to make copies of all of Bobby's wife's assets so he could get his share? Do you remember how Evandler Holyfield tried to hide 9 million from his wife by letting Dr. Creaflo Dollar keep it, and his wife got a subpoena for Creaflo Dollar and he left town because they were going to arrest him. Evander Holyfield straighten up the books...

You have never paid one dime on the renters insurance (\$146.00 year), you have never contributed one cent to any of the legal work that I have done for us and last month alone I spent over \$405.00. You have never help me pay one dime back to Delores for the \$10,000 that I borrowed and we used. I would never be so petty as to try to destroy you like you have done to me. You have been very unappreciative for my taking you to work everyday for six months before you got "your" car, and for me taking care of both your cadillacs, and doing all the grocery shopping and cooking breakfast & dinner for the last 3 years. You also lived free for the first six months when we moved on Par Three, while you saved all your money. You even loaned Eric \$2,500.00 without asking me, of which 50% rightly belonged to me. In February J.R. got arrested and you got \$1,200.00 out of our savings account for him without consulting me.

CONCLUSION

Because of all of the above, I will not pay you any rent, or any portion thereof for the months of May, June and July which will give me a chance to catch up my bills and save me some money too, and If you don't like it you can always hire a lawyer and I'll beat him and he'll break you.

You were the cause of both of us going to prison and I will share some of the information with you that I've had since 1995, and you were Guilty as hell. However, I have never been angry with you and I have fought diligently for you and I both, because we were both framed. It just leave me speechless for you to have done everything to "undermine" all the legal work because you were truly a "scared house Negro", so you would Not support me financially, spiritually or in any way what-so-ever. I strongly suggest that you read all this information in its entirety, because when you see it again, you should be prepared to respond to it.

I still dearly Love you but I can never trust you again because I have truly been "sleeping with my worst enemy."

THE MARRIAGE VOWS

We are gathered here this day to unite this man, George High and this woman, Virginia Coleman in the bonds of holy matrimony which is an honorable estate. Into this, these two now come to be joined.

If anyone present can show just and legal cause why they may not be joined, let them speak now or forever hold their peace.

Who gives this woman to this man?

(MAN) George High, will you have this woman as your lawful wedded wife, to live together in the estate of matrimony? Will you love her, honor her, comfort her, and keep her in sickness and in health; forsaking all others, be true to her as long as you both shall live? (I will).

(WOMAN) Virginia Coleman, will you have this man as your lawful wedded husband, to live together in the estate of matrimony? Will you love him, honor him, comfort him, and keep him in sickness and in health; forsaking all others, be true to him as long as you both shall live? (I will).

Please join hands and repeat after me:

I, George High, take Virginia Coleman as my wedded wife, to have and to hold from this day forward, for better or for worse, for richer or for poorer, in sickness and in health, to love and to cherish, till death do us part.

I, Virginia Coleman, take George High as my wedded husband, to have and to hold from this day forward, for better or for worse, for richer or for poorer, in sickness and in health, to love and to cherish, till death do us part.

For as much as George High and Virginia Coleman have consented together in wedlock, and have witnessed the same before this company of friends and family, and have given and pledged their promises to each other, and have declared the same by joining hands.

By the authority vested in me by the State of Georgia,

Virginia: I write this letter with a very heavy heart, as I have tried since 1966 to make this relationship work, all to no avail, because you have done everything in your power to destroy me. As has always been my policy and so will it continue to be; I never make unfounded charges, accusations, allegations or just flat-out-lies, without supporting documentation....

If there was such a thing as “the straw that broke the camels back”, then it would have had to began Friday morning (7/27/07), when for no apparent reason you just started saying the most nasty and hateful things about me and continued for 30-40 minutes until I actually started crying. To add insult to injury, when you came in from work Friday evening you told me to call the Mr. Brodis about you getting this house refinanced and I told you that you that I had talked to him twice but was not able to give him accurate information because you had refused to give me the closing statements. At that point you began to tell me that they changed the loan amount after you closed and the attorney came to your job to do the closing which only took 10 minutes and you got \$2,500.00 cash back at closing. You told me that you did not read the closing statements and did not realize what you were signing and the loan amount was only suppose to be \$155,00.00 but it was in fact \$165,00000 +. I told you that you were a real agent and had been to 50-60 closing and I find it hard to believe that you just blindly signed some documents. At that point you started on me again saying everything nasty that you could think of and I gave you the comps and that Dekalb County tax information and told you that I was not handling it because you were not being truthful and I refused to argue with you or to even speak to you until Saturday night when you came in and you started insulting me again.

Virginia, let me say right here that since 1971, we have owned over 100 pieces of real estate and I was the deal-maker on each and every one of them and I always bought below market and I might add that in 1990, we were worth 4-5 million thanks to me, before the USA framed and wrongly convicted us and caused us to spend over 7 years in prison. Since 2001 when we got out of prison, I have never been able to discuss any issue with you because you always get loud and start talking about me so as to evade the issue. In June of 2005 you put me out so I moved to park trace apartments, where I stayed for 2 years and during that time I wrote my book Disfranchised started my website www.georgehigh.com , for the sole purpose of getting our judgment & conviction vacated, sentenced overturned, all rights restored and all monies rightfully due to be paid to us. Also during that time you got a devoice stating that one of the reasons for the devoice was because I had walked out on my prior wife in 1968 just as I had walked out on you in 2005. The only thing that I requested and you agreed to was to have your name changed back to Coleman, which you agreed to do, but as of this day you are about 1 ½ years overdue and in contempt of court. On or about May 13, 2007 J.R. Had my cell phone and you called and he answered and you said you wanted to speak to me. When J.R. came by later to pick up Victor he said you had called and he asked me if I had talked to you and I told him the last time I saw you or spoke to you was at his house on Christmas day.

The next day or so, you called and said you missed me and wanted to see me and you asked me to come by so we could talk. I came over to your house and we talked and you gave me the keys to the front door and a set of car keys and you asked me to spend the night. The next day you took your clothes from one side of the closet in the master bedroom and moved them in the guest room. Now from the day we moved in this house I never had anything in the master bedroom, the master closet nor the master bath, so that was some change. I told you that I had just signed a

lease for another year effective June 1, 2007. After much coaxing, I agreed to cancel the new lease and move back with the understanding that we would be as one.

Now un-be-known to me at the time, your 2 nieces had just moved out because you had raised their rent for no apparent reason, other than the fact that they did not have a lease with you. As you were aware, my rent was \$177.00 monthly and the new amount was \$148.00 and my total income was \$650.00 monthly. After I moved in

400.0 Clean all gutters and down spouts cut grass 5-6 times.

\$85.55 lawnmower

\$116.27 paid BellSouth 7/11

\$57.10 Scana Energy

\$150.00 4 hours working on refrigerator

\$225.00 replace sink spray at kitchen sink. Repair leak in downstairs bath. Purchase and install flanges on 3 supply lines.

\$5,416.00 Total

In light of the above, I will not pay any additional monies toward any bills and If you wish me to move, you can buy the remaining balance that was due on my lease \$177.00 monthly through May 2008, which is rightfully the amount I should pay here. You also owe half of the amounts of each of the IRS refunds that you stole from me after filing a joint tax return for 2001, 2002, 2003, 2004, 2005 and 2006. You are not my enemy and I have no fight with you, but since you chose to treat me as an houseboy, lackey, flunkey because I have done all of the grocery shopping (with my money), and done all of the cooking, except on those special days when your children and grand's are coming over to dinner. I might add that since 2001 you have taken off days for everyone and everything but me and you and I have never taken vacation together since 1993. This year is no different from the last 7, when you go to visit your folks in Washington, Ga. For Homecoming and this year Family reunion. I have never been to visit any of your family with you since 1993, because you do not want them to know the truth about us spending 7+ years in prison. You got your devoice, you got your house, your bank accounts, your 401, your insurance, your family, your sons, their wives and your grandchildren and your job. No matter what you do to me, I will never forget that you and I were married for 40 years and you will never be my enemy, but don't push me.

I have proof for all of the above.

I had written a 2-page letter relating to the incidents of the last 2 weeks, but I decided to just simply comply with your wishes and move out of your house ASAP. Let me be crystal clear so there will be no surprises or ill feelings in the event we cannot come to a meeting of the minds, and this matter ends up in court. That being the case, all bets are off and this letter will become null & void. If you agree to the following, I am requesting that you do so in writing, because we do not need any he said she said. My Demands are as followed and are non negotiable.

Repay me the **\$449.36** Insurance I paid for the truck.... Statement enclosed

Repay me the **\$228.29** Insurance I paid for your Cadillac... Statement enclosed

Pay me **\$850.00** from the IRS tax returns for Past years and that matter will be forever closed and I will/can never bring any action against you or Eric nor under any circumstances.

The above amounts must be paid before I move out so I can have money to pay my rent & security deposit. I made Application at Park Trace and Ms. Robinson called and said my application was approved and I was at the top of the waiting list and should be able to move in the 1st week in September. Since I made 2 payments on the truck thru September 11, I am requesting to use it until that date. If you agree or disagree with the above, put it in writing and there will be no hard feelings and I am waiving all of the below monies that I spent during my stay here.

\$1,232.08 I have records proving that I spent that amount from 5/17 thru 5/30.

\$200.cash

\$800.00 from the sale of pickup in June.

\$200.00 bought and installed garbage disposal.

\$150.00 Install new bottom in cabinet

\$1,200.00 Cut down 7 trees, cut up and haul to streets

\$600.00 clean undergrowth from side lot and haul to street 5 days.

400.0 Clean all gutters and down spouts cut grass 5-6 times.

\$85.55 lawnmower

\$116.27 paid BellSouth 7/11

\$57.10 Scana Energy

\$150.00 4 hours working on refrigerator
